

NORTH YORKSHIRE CLASSIC CAR HIRE **TERMS AND CONDITIONS**

HIRER The person or persons booked and entitled to drive

OWNER North Yorkshire Classic Car Hire (NYCCH)

DRIVER(S) The person or persons booked and entitled to drive

GENERAL

- 1 All drivers must be aged between 25 years and 70 years and must have held a full driving licence for at least 2 years.
- 2 Driver(s) must produce a clean driving licence on collection of the vehicle.
- 3 Drivers holding foreign driving licence will be subject to referral to our Insurers. We reserve the right to refuse hire at our own discretion.

INSURANCE

- 4 All vehicles are insured during hire on NYCCH fully comprehensive policy.
- 5 Each vehicle is covered by a breakdown and recovery scheme.
- 6 Hirer is responsible for ensuring vehicle is locked and secure whilst unattended and any security device supplied is used.
- 7 Hirer agrees not to drive in a negligent manner, and non-accidental damage is the responsibility of the Hirer and as such must be paid for by the Hirer.
- 8 Excess varies from vehicle to vehicle and this is will be advised at time of booking
- 9 Additional charges will apply if you fail to return the vehicle by the specified time and date. Please note you will not be covered by our Insurance during any unauthorised period and will be required to indemnify NYCCH for any loss, damage or injury resulting from any accident taking place during this time.
- 10 Hire is subject to your acceptance of our Terms and Insurance Conditions and Fees.
- Hire is subject to you being accepted by our Insurance Company. Any surcharge imposed by our Insurers because of your driver history, or any unusual hire details will be charged to you.
- 12 No driver under 25 years of age or over 70 years of age.
- 13 No person who has had motor insurance refused/declined.
- 14 No driver with mental or physical defect or infirmity; major medical complaint; suffering from fits.
- 15 No driver banned from driving or having 3+ penalty points imposed.
- 16 Certain professions are excluded by our Insurers. Check at time of booking.
- 17 No driver having had more than 1 insurance claim in last 3 years.
- 18 Extra driver insurance quoted on individual basis for each car.
- 19 Full Driving Licence and Counterpart (if appropriate) must be produced at commencement of hire, together with proof of residence (ie. utility or council tax bill in same name).
- 20 Photo ID (or passport) must be produced if no counterpart licence.
- 21 NYCCH Insurance covers use of vehicle for social, domestic and pleasure purposes by the permitted driver(s) only whilst on hire; it does not cover use of vehicle for racing, pace making, reliability trials, competition, towing or driving tuition.
- 22 Vehicle should not be used for illegal activity and must not be taken out of the UK.
- 23 If the vehicle is returned later than agreed, you will not be covered by NYCCH Insurance for any such unauthorised period.
- 24 Any accident or incident involving the vehicle MUST be reported to the NYCCH immediately, however minor.
- 25 In case of accident your are required to a) obtain names and addresses of anyone involved in the accident and any witnesses; make no admission of liability; deliver all summonses, writs and other documents received to the this company; not aid or abet any claimant but co-operate fully with us and our Insurance company in the investigation and any defence of any claim made against us.
- 26 Do not allow anyone to work on the vehicle for any reason without our express permission. If work is given permission, we will only make a refund if you produce a receipt for such work.
- 27 The hire vehicle may only be driven on sealed bitumen road surfaces.

SECURITY AND CDW

- 28 Before the hire starts you must leave a credit card deposit, normally £800, held by NYCCH as:
- a) security bond;
- b) payment towards mechanical damage not covered by insurance, ie. tyre, wheel or clutch damage caused during hire;
- c) Insurance excess against accidental damage or loss caused to the vehicle by a third party or the hirer;
- d) recovery, towing or storage costs if the vehicle is stolen, lost or damaged prior to return by the Hirer or its recovery by the NYCCH.

(Provided you return the vehicle to us at the end of the hire period in the same condition as when you collected it, and other charges are not payable, we will not make any charge on your card.)

- 29 The card may be used by us if additional charges are incurred ie. fuel, damage or other miscellaneous charges mentioned in our Terms and Conditions. Other costs include reasonable legal costs incurred by NYCCH in collecting any overdue payments due from the Hirer.
- 30 **CDW** can be arranged at time of booking from £6 per day per driver depending on car, to cover insurance excess in the event of collision damage, fire, theft or glass damage.
- 31 Taking CDW cover will reduce your security bond to £300.
- 32 Fines, penalties, court costs or other expenses imposed on NYCCH by law arising from use of the vehicle whilst on hire will become payable by the Hirer. (ie. speeding or other motoring offences, parking fines, clamping etc.).
- 33 Theft of or loss or damage to personal property left in the vehicle by the Hirer is not the responsibility of NYCCH.
- 34 If the vehicle is returned in such a condition that extra valeting is required, you will be responsible for the valeting charge.
- 35 Fuel level will be noted at start of hire and you will be requested to return the vehicle with a similar level of fuel. Failure to do so will result in a charge to cover the fuel at cost, plus £10 service charge.
- 36 Smoking is not allowed in our vehicles, neither are pets. Additional cleaning charges will be incurred if you fail to comply with this condition.

BOOKING DETAILS

- 37 Car hire reservations may be made with a non refundable deposit of 25% of the hire charge. Hire charges will become due 60 days prior to start of hire. (Short notice bookings accepted subject to availability).
- 38 Accommodation reservations will be advised separately, usually 10% at time of booking
- 39 Single day hire can be for any length of time from 9am to 6pm. Multiple days hire can be any number of days from 9am on first day to 6pm (or by arrangement) on last day.
- 40 Delivery / collection of the vehicle will normally be at our depot at Easingwold, but delivery / collection at an alternative venue can be arranged. Charges may apply please ring to discuss.
- 41 In the event that your chosen vehicle is not available a similar alternative will be offered. If an alternative cannot be offered our responsibility is limited to the refund of any payments made to us.
- 42 We reserve the right to restrict vehicle movement in some areas of the country due to adverse weather conditions or other reasonable causes.
- 44 A re-arrangement fee of 25% will be made if you give less than 30 days notice of change of booking. We recommend therefore that you take out independent travel insurance to cover cancellation due to circumstances beyond your control.
 - No refund will be made for cancellations with less than 60 days notice.
- 46 GIFT VOUCHERS. Vouchers are valid for 1 year from date on voucher. Vouchers may be used for any driver/vehicle but are non-refundable.
- 47 By making a booking you agree to these terms and conditions. You will be required to sign our standard Rental Agreement before the hire commences. You agree to accept the debit to your card account of the charges incurred under our Agreement.
